DOMESTIC VIOLENCE CE REMINDER

Nurses with active licensure status on July 15, 1996 have a mandatory, one-time requirement to earn three hours of Kentucky Board of Nursing approved domestic violence continuing education (CE) before July 1, 1999. Any nurse licensed after July 15, 1996 has three years from the date of initial licensure to earn the CE requirement. **Compliance monitoring will begin with the 1999 licensed practical nurse renewal. Thus, most registered nurses renewing in 1998 need to earn the domestic violence CE prior to June 30, 1999, but will not be audited until after the year 2000 renewal.**

Any KBN approved CE provider may offer the mandatory domestic violence course using the approved model curriculum provided that, as a minimum, the following content is included:

... the dynamics of domestic violence, effects of domestic violence on adults and child victims, legal remedies for protection, lethality and risk issues, model protocols for addressing domestic violence, available community resources and victim services, and reporting requirements.

SEXUAL ASSAULT NURSE EXAMINER PROGRAM

The Sexual Assault Nurse Examiner (SANE) Program at King's Daughters' Medical Center, Ashland, has been approved by the Kentucky Board of Nursing. HIGHLIGHTS OF BOARD ACTIVITIES

- Requested additional information regarding a letter from Cynthia Keeney, Executive Director, Kentucky Hospital Association Center for Nursing and Allied Health Professions, that suggested a study on unlicensed personnel, following guidelines of HCR 79, be initiated by the Center in conjunction with the Board of Nursing.
- Directed that work groups be established to address competency issues, strategic planning, and Board/committee structure.
- Directed that the Consumer Protection Committee further address diversion programs and “stay of suspension” term for disciplinary actions.
- Directed that during the next six months, default judgments be used in administrative hearings only in CE and bad check cases. Staff were directed to notify the Attorney General’s office of the decision to pilot default judgments in these type of hearings. This process will continue to be evaluated.
- Approved the “Guidelines for Review of Criminal Convictions and Disciplinary Actions from Other Jurisdictions” (ID-1) and the “Guidelines for Release of Data” (IR-1), as revised.
- Approved proposed revisions to the following Kentucky administrative regulations:
 - 201 KAR 20:070 Licensure by Examination
 - 201 KAR 20:110 Licensure by Endorsement
 - 201 KAR 20:240 Fees for Applications & for Services
 - 201 KAR 20:260 Organization & Administration Standards for Prelicensure Programs of Nursing
 - 201 KAR 20:370 Applications for Licensure & Registration
 - 201 KAR 20:091 Repeal of 201 KAR 20:090, Temporary Work Permit
- Approved revised advisory opinion statements: “School Nursing Practice” (#93-30) and “Implementation of Patient Care Orders by Nurses” (#87-14).
- Approved the letters of response to opinion requests regarding use of ready to mix intravenous infusion systems by LPNs; deployment of extravascular hemostasis devices by RNs; and performance of foot care by nurses.
- Directed that regulatory language be developed addressing the requirements for RNs to practice in the prehospital emergency services arena. Further directed that the Education Committee evaluate prelicensure RN education curricula for prehospital emergency nursing content.
- Directed that the following prelicensure nursing programs be issued letters of congratulations for a 100 percent FY 96-97 NCLEX pass rate: ADN Program, Southeast Community College, Cumberland; and Kentucky-Tech PN Programs at Elizabethtown, Hazard, and West Kentucky in Paducah.
- Accepted a change of governance for the ADN Program, Owensboro Extension, Henderson Community College, to Owensboro Community College.
- Approved the University of North Carolina at Chapel Hill RN refresher program.
- Accepted the proposed revisions to the medication aide curriculum submitted by the Workforce Development Cabinet.

The format for reporting disciplinary actions includes the statutory citation of the violation. KRS 314.091(1) lists the following grounds for disciplinary action:

- (a) guilty of fraud or deceit in attempting to procure a license;
- (b) conviction of a misdemeanor or felony;
- (c) conviction of a sexual abuse offense;
- (d) acted in a manner inconsistent with the practice of nursing;
- (e) unfit or incompetent to practice nursing;
- (f) abused use of controlled substances or misused or misappropriated any drugs;
- (g) made incorrect entries or failed to make essential entries;
- (h) action on license in another state;
- (i) violated any of the provisions of this chapter, or violated any lawful order or directive previously entered by the board, or any administrative regulation promulgated by the board.

NURSING COMPETENCE FROM A REGULATORY PERSPECTIVE

The Kentucky Board of Nursing announces the formation of a task force to study nursing competence from a regulatory perspective. The group held its initial meeting September 10, 1998. The mission of the task force is to "Reach consensus on a regulatory approach to validate nursing competence." Specified objectives are to:

1. Foster pertinent dialogue and debate about the validation of competence for nursing licensure.
2. Propose operational models for initial and continuing competency validation.
3. Communicate a shared vision of nursing competence for entering the 21st Century.

Task force membership includes representatives from the Kentucky Board of Nursing, Kentucky Nurses' Association, Kentucky State Association of Licensed Practical Nurses, Kentucky Coalition of Nurse Practitioners, Kentucky Home Health Association, Kentucky Hospital Association, and nursing education and practice. Participation by representatives of other organizations will be added as the task force begins its work.

Both the Kentucky Board of Nursing and the Competency Task Force are committed to open communication about competency validation issues with the consumers of nursing services, and our nursing and health care colleagues. The work of the task force will assist the Board as it considers regulatory changes to assure public protection as it serves the citizens of the Commonwealth.
